

## Walleye Stocking Report

The Lake Miliona Association works with the DNR on walleye stocking plans to achieve a balance of all species. The DNR normally stocks walleye fry in the spring and walleye fingerlings in the fall based on the results of previous fall electro-shocking tests. The DNR electro-shock survey in the fall of 2010 yielded a young walleye rate of 15 per hour, substantially lower than the 124 per hour rate in 2009. As a result, the Lake Miliona Association, working in conjunction with Viking Sportsmen of Alexandria, stocked 540 pounds of six inch to ten inch walleye fingerlings in Lake Miliona in December. The larger (yearling) fingerlings

were recommended by the DNR to achieve a higher survival rate.

In 2010, the DNR did not stock walleye fingerlings, however, they supplemented their fry stocking program from a planned 2.9 million fry to an actual 4.2 million fry. This increased the base rate of 1,000 fry per littoral acre to about 1,450 per littoral acre.

This year, the DNR plans to stock 2.8 million walleye fry and potentially stock walleye fingerlings in the fall based on their electro-shock survey.

Generous contributions from our members, sportsmen's clubs, guide services and tournament organizers, has allowed us to fund over \$30,000 in fry and

fingerlings in the last five years. Your contributions over the years have effectively populated Lake Miliona with a healthy supply of yearling and second-year class walleyes. Many 10 to 15 inch walleyes were caught and released this past season to sustain an acceptable population of walleyes in the lake.

The Lake Miliona Association board of directors will again consider a plan to continue to participate, subject to DNR approval, in the Viking Sportsmen matching program. The quantities of fingerlings and fry stocked in the next two years may vary based on an optimum use of resources and management of the walleye population.

## Walleye Angling Survey

In March the Fisheries Committee conducted a survey of Lake Miliona area anglers. The questionnaire was transmitted to 215 email participants in our database of about 700 in our community. We are pleased with the response rate of 48% and the information learned from data returned.

Our primary objectives were to determine the catch rate of various size walleyes, the frequency of catch and the release rate within each size category. The three size categories are: less than 15 inches, 15 to 21 inches and greater than 21 inches.

The responses indicated that 68% of the walleyes caught were less than 15 inches in length and 86% were released; 27% were between 15 and 21 inches with a 27% release rate; and, 5% were greater than 21 inches with a 90% release rate. The fisheries committee is pleased to see the high percentage release rate in the small and large size categories. We also find that the Association's effort to maintain a healthy supply of young walleye in the lake is proving successful.

We are also pleased with the catch rate per angler hour. Our overall average walleye count per angler hour was 1.05. The data proved to be very consistent with only 6 of 104 responses falling

outside 2 standard deviations of the mean.

Another way of stating the catch rate is that, on average, an angler needs to spend less than one hour to catch a walleye, and there is a 32% chance that it will be greater than 15 inches in length. And, in one hour, on average, an angler would have a 5% chance of catching a walleye greater than 21 inches.

The fisheries committee thanks the respondents for their input. An electronic copy of the summary data has been transmitted to them. We expect to repeat this survey annually to help identify trends that will further assist in the management of walleyes in Lake Miliona.

assortment of current colors, fabrics, and styles. And while supplies last, all remaining inventory from 2010 will sold at fire sale prices!



Once again the Miltona Lake Association will be working with the DNR to perform boat inspections on our lake. Last year a grant allowed us to pay one half the cost for the DNR to perform 112 hours of boat inspections. This year a grant increased our hours to 250. That maybe true but how many times have you heard the saying "he beat the odds", "one in million" or "you have three months to live". It is human nature to fight and not give up and that is what we are doing to keep our lake free of Zebra Mussels.

## Smoke Signals From The Camp

Like all lakeshore residents, Smokey Timbers Camp's Voluntary Board, with lots of great help from "Friends of the Camp" is busily preparing for another summer season. The work began robustly on May 4th when nearly 40 Skills U.S.A. students and staff from the Alexandria Technical College spent the day repairing the deck, doing equipment maintenance, raking, trail blazing, wood cutting, readying the waterfront, etc. The highlight of the day was the setup of a new pump house that had been prefabricated at the College. Located adjacent to the main entrance, it affords a vastly improved first impression of the facility.

The Camp is anticipating the best year of activity yet since the transfer of ownership to the Smokey Timbers Foundation. By the first of March activities were scheduled for virtually every summer weekend. A variety of weekday events have been scheduled as well. Included are YMCA day camps and family overnights, Boy and Girl Scout outings, church groups, school events, a forestry workshop, and family gatherings. On June 7th the Miltona Science Magnet School will be having an environmental education field day at the Camp. This event was made possible, in part, by an Environmental Education Partnership fundraiser held by the Foundation and the School this past March. The increasing number and variety of

activities taking place at the Camp reinforces the Foundation's vision for Smokey Timbers.

**The Camp's annual fish fry, to which all Lake Association members are invited, is scheduled for August 6th this year.** Be sure to mark your calendar for this increasingly popular event.

Fundraising, of course, continues to be a major challenge for the Foundation. On-going operational expenses prove to be manageable through the typical flow of revenue from user fees, regular contributions, and support from area organizations. A substantial portion of the debt incurred as part of the "rescue" by local citizens when the property was put up for sale in 2004, however, remains and was passed on to the Foundation along with the ownership transfer. Annual principal and interest payments make vigorous pursuit of the Camp's mission difficult. An added burden this past year occurred when the Oct. wind storm toppled numerous trees on the grounds, one of which flattened one of the campsite shelters.

## Lake Miltona Water Quality Monitoring

The Lake Miltona Association was awarded a grant from the MPCA as part of a program submitted by Emily Siira, of the Douglas County Soil and Water District, to monitor two sites as part of the MPCA Long Prairie Watershed monitoring plan. These two sites are the inlets to Lake Miltona: the stream from Lake Irene and the Dittberner Creek. Monitoring will be done at these two sites two times per month during May through September. The evaluations to be performed include both physical measurements (dissolved oxygen, pH, transmission-tube, conductivity, temperature, as well as observations such as water level and photos): and collection of samples for chemical and biological analyses (nitrogen, nitrite, phosphorous, total suspended solids, total suspended volatile solids and E. coli). All of the costs of the analyses are covered in the grant. The grant will also cover obtaining monitoring equipment (for flow, temperature, oxygen, etc. measurements) and time for Emily Siira to accompany and help our volunteer make measurements.

Representatives of our Lake Miltona Association attended the Kick-Off Event of the overall MPCA Watershed Restoration and Protection Project for the Red Eye and Long Prairie Watersheds on April 12, 2011 at the Prairie Event Center in Parkers Prairie, MN. In addition to this watershed activity, we will continue our current Lake Association monitoring activities on the lake.

## Lake Scaping Article


There has been much discussion recently about our desire to re-create a suburban-type lawn versus going native. Most will agree that our well-deserved weekends at the lake shouldn't be spent mowing the lawn. But the question always arises "Where do we start if we want to restore a more native environment to our lakeshore?"

Lakeshore Restoration is the establishment of a shore land buffer of native grasses, wildflowers, shrubs, trees and aquatics. Plants in shore land buffers will filter pollutants, stabilize sediments in the water, reduce shoreline erosion, and provide wildlife habitat.

The best projects are not overly large or expensive and are the ones that evaluate the site well, use existing features, keep up with maintenance, and examine the whole area, from the land out into the water. Effective buffer zones should be along at least 75% of a property's water frontage and extend

16 to 25 feet or more from the water's edge onto the land. The wider the buffer zone the better it will function.

Lakeshore restoration begins with evaluating what you want out of your shoreline. Determine what uses are important and necessary to properly enjoy your shoreline by asking if you like sitting by the water, watching sunsets, or really only want a walking path to your dock. Once you decide what you need for your uses, evaluation of your site's physical conditions can begin--examine sun and moisture conditions and determine the size of your planting area.



Even though a restored shoreline is a lower maintenance alternative to traditional lawns, some maintenance is still needed to preserve your

investment. Frequent watering immediately after planting is just as important as continued weeding after establishment.

Grants are available on a first come, first served basis through a variety of sources and can cover up to 75% of the total cost of the project, including labor. The Lake Miliona Association also has funds set aside to help property owners fund a portion of the project. There are other restrictions, maximum limits to the grants, and often require a 10 year commitment.

Depending on the size and scope of the restoration, a project could be initiated this summer for an early autumn planting. And it's not too soon to think for early 2012.
